U.S. Customs and Border Protection (CBP) had announced the **indefinite suspension** of the *de minimis* administrative exemption under 19 U.S.C. § 1321(a)(2)(C) for imports valued at \$800 or less arriving through the international postal network by regulation. Effective July 24, 2026, such merchandise may now be entered under the new postal informal entry process announced in the [FR Notice by U.S. CBP, published on 06/24/26](#). This new postal informal entry process will generally be applicable to merchandise valued at \$2,500 or less.
