- [USTR Makes Findings & Proposes Action in 60 Sec.301 Investigations Relating to Failures to Take Action on Trade in Forced Labor Goods pursuant to Supreme Court Upholding CAFC Decision on Sec.301 Tariffs from China](#) imposed during President Trump's first term. This means that the ruling will continue to be imposed with potential for further products and/or countries being added to the Sec. 301 tariff action. To be assured of consideration, interested persons should submit requests to appear at the hearings, along with a summary of testimony by June 22, 2026. Written comments are due by July 6, 2026. USTR will hold hearings about the proposed actions in these investigations on July 7, 2026.
