Following the Supreme Court ruling on February 20, 2026, President Trump issued an [Executive Order](#) “Ending Certain Tariff Actions.” U.S. Customs and Border Protection (CBP) subsequently issued [CSMS # 67823350 - Supreme Court of the United States \(SCOTUS\) Judgment - International Emergency Economic Powers Act \(IEEPA\) Tariffs](#) confirming that additional guidance would be provided. This was followed by [CSMS # 67834313 - Ending Collection of International Emergency Economic Powers Act Duties](#), on February 22. That same day, the White House issued a [Proclamation](#) and [Fact Sheet](#) authorizing new [Section 122 tariffs \(Trade Act of 1974\)](#) of up to 10% on all goods, for a period of 150 days, excluding certain items listed in [Annex I](#) and [Annex II](#).

The [Proclamation](#) also provides an in-transit exemption for goods that:

- Were loaded onto a vessel at the port of loading and in transit on the final mode of transit prior to entry into the United States, before 12:01 a.m. EST on February 24, 2026; and
- Are entered for consumption, or withdrawn from warehouse for consumption, before 12:01 a.m. EST, February 28, 2026.
